4. Parental consent must be received for minor participants.
5. A waiver must be signed prior to participation.
6. Registration **must** take place in the Exhibition Office. Registration closes two (2) hours before the event start time.

Participant will receive two (2) Day Passes to cover entry into the grounds for the Participant and one (1) Attendant/Helper. Run order will be determined on entries.
